- ❖ Don has taken the equipment home and reorganized it to consolidate many of the items so that we are carrying around less of the equipment.

Marketing

- ❖ Alisa has been advertising on Facebook about our monthly lessons and dances. We discussed the possibility of making a 'page' vs. a group on Facebook. Also discussed was the possibility of adding the rest of the board members on Facebook so more people can be invited.

- ❖ July's theme will be a summer picnic and August's theme will be an ice cream social.

Education

- ❖ In 2012, there are four months with 5th Fridays. We will keep the dates open for the months of March, June, and August but will eliminate the November date with Joanne (Franklin Park Park District).
- ❖ Plans are underway for next year to have a "MEET YOUR TEACHERS NIGHT" where the teachers will become our Dance Angels. Stay-tuned!

He also recommended that we add a column to the member database for volunteering. When members pay their annual membership fee, they can be asked if they would want to volunteer.

Membership Drive

- ❖ At our May meeting, Leah passed out a new schedule for SNC Membership. We were all supposed to review it and bring comments to the June meeting. The board needed another month to review the materials. It was tabled until our July meeting.
- ❖ To review briefly, the pro-rating procedures will get everyone changed over to having their annual membership fee being due in September with no cost increase.

Life Membership

- ❖ Discussion was held regarding allowing spouses of Life members in for free. Karen moved and Leah seconded that spouses of Life members will not be admitted freely. One abstained and one opposed. **Motion carried.**

Volunteers

- ❖ Deborah has recruited one new volunteer this past month, bringing our total to 9. We will keep recruiting to get the list a little bigger.

Dance Angels

- ❖ It was suggested to consider recruiting Dance Angels in “Happenings”, along with having the board members that work the table ask people as they come in if they are interested in being a dance angel for the evening.
- ❖ Dance Angels earn 2 points for 1 hour and should not be dancing with each other.
- ❖ It was suggested that all board members ask at least 2 people to dance that are sitting along the walls. This would increase the effect of “Dance Angels”.
